### **Where Are We On Lake Control?**

Like most Lake Sarah residents, I am disappointed in the progress to improve our lake. We have heard many proposals to rid the lake of weeds but no real solution has emerged. Some of the experimental programs such as at Medicine Lake are now proving to be less than satisfying. Some of the Lake Minnetonka bays have shown great improvement but it is the flow of fresh water and springs that are helping those treatments. I have heard about wievels that will eat lake weeds. Unfortunately, most of them end-up in the stomach of sunfish who are very fond of them. Suggestions of whole lake treatments are very expensive and most lake communities can not or will not spend the money.



So what can we do with what we have where we are. Each of us can take care of our own shoreline. This means either removing the weeds with rakes (which is what I intend to do) or pay for one of the lake water treatment companies to apply chemicals on the beach in front of our properties. The first suggestion does require some work but no chemicals need be used and the work can be done whenever the homeowner wishes. It may be unpopular but is much less expensive. The second alternative is for those who prefer to have professionals do the work.

There is no feasible plan at this time to treat the open areas of the lake. Your LSIA Board of Directors has been looking into the possibility of a harvester system for the open areas but no conclusion has been reached on that idea. Suggestions from the membership are more than welcome - they are greatly desired! Please contact any of the LSIA members of the Board with your ideas. Even better, volunteer to serve on LSIA committees to help find solutions to these lake problems. Lake Sarah belongs to all of us and everyone's thoughts and, especially, help are what will make our lake organization more effective.

## Lake Sarah Fishing

---

The DNR reported that ice fishing enthusiasts in general did not make their regular appearance on Minnesota lakes this year as they have done in past years. This is true for Lake Sarah as well. The number of ice fishing houses declined from 342 last year to 6 this year. This is good news as there is less fishing pressure on Lake Sarah's already overfished crappie population. In fact, a few Lake Sarah anglers reported that they felt the crappie population is down from past years. Some believe this to be a slow decline of a popular metro lake, however, it is quite assuredly normal to have regular cycles of fish populations. In an effort to help maintain crappie levels and locally curb the rise in unlicensed fisherman, this year conservation officer, Dephong Lee, visited several anglers on Lake Sarah.



## Walleye Stocking Update

---



Lake Sarah walleye are most likely now in the 10-12 inch stage and feeding primarily at night in the deep ravines, particularly in the muddy deep areas. This is the stage when they make a major change of diet and will likely start showing up sporadically on the end of a line. However, of the fish that have been stocked we can expect high mortality in this class as it is a favorite size for aggressive predators like northern and dogfish (bowfin). In addition, the walleye will tend to migrate more as they search for sustenance which can make them even more of a target.

Lake Sarah was not stocked last year so we can separate the class of fish. Depending on the amount of funding raised, we may stock as many as 1,500 fingerlings in the fall of 2010. Your contributions and in put are greatly appreciated and will pay off through the years. Incidentally, the last known large walleye to come from Lake Sarah was a whopping 10 pounds! It was stocked in the lake by Bud Eppel of Elm Beach Resort. It was said that he had a habit of sorting through the minnows and letting the walleye minnows go rather than sell them as bait.
