A Message From Your LSIA President

After one of the warmest winters ever, Spring greetings to you all!

Since our fall newsletter and membership meeting, we have been busy building on the momentum created in 2011 and are making meaningful strides toward fulfilling our association's mission of improving Lake Sarah. Some notable accomplishments worth highlighting are:

- 1. We submitted our draft Lake Vegetation Management Plan (LVMP) to the DNR in early January. This is a required step in the journey of gaining the DNR's approval for whole-lake treatment of CurlyLeaf Pondweed (CLP) and Eurasion WaterMilfoil (EWM), our two primary Aquatic Invasive Species (AIS). While weeds provide a critical role in a well balanced lake ecosystem, these two invasive weeds are clearly dominating our native weed species, resulting in restricted boat use (due to weeds matting on the surface). In addition, the Curly Leaf Pondweed contributes to a large spike in phosphorus being released that leads to severe algae blooms during our peak summer months. Our LVMP goal is to aggressively control to greatly reduce if not eliminate these two invasive species allowing the native vegetation to become re-established. We hope to get our LVMP approved by the DNR sometime this year.
- 2. As part of our LVMP process, we proposed and received verbal approval from the DNR to move forward with a "pilot treatment" program this spring that would allow trained volunteers from our association to treat a limited amount of CLP and EWM. The goals of these pilots are to prove out our treatment process to ensure we can do them both safely and cost effectively. It is our clear belief that by managing this process ourselves with responsible volunteers, we can ensure the timing of our treatment is under optimal conditions and the cost of application is less than half of what professional lake applicators would charge.
- 3. We sourced knowledgeable expertise via Aquatic Solutions to guide us on the best application approach, using the most effective early season low dose herbicides available at a very cost competitive wholesale level.
- 4. We held 3 educational meetings for members in February to learn of the process and form various "blocks" for treatment this spring, and the interest for the pilot program was greater than we anticipated.
- 5. We submitted our permit and variance request to the DNR in early March, along with an AIS grant application that if successful would fund just about half of the cost of the program. This pilot program will be paid for (net of any grant benefit) by the 65 lakeshore owners who signed up.

In summary, we are pleased to announce that on April 18th the DNR approved our permit for up to 50 acres! While we did not get the variance for additional acres approved, we want to assure everyone who signed up will still get treatment (just a slighlty scaled back area).

By the Spring Membership meeting on April 26th, we expect to have completed all treatments. Whether or not you are part of the pilot program, please come to the meeting for a first hand update – and learn further as to our longer term vision for whole-lake treatments.

There is not a better time to become an active member of the Lake Sarah Improvement Association, and to personally engage in the journey we are on to noticeably improve our lake water quality - our lake community as a whole – and our lake area property values! Please consider renewing and or joining the LSIA today (membership form included in this newsletter).

most unusual conditions that I have seen in the past 20 years of living on the lake. Pressure


ridges, open water, and thin ice. I would like to thank Brad for keeping the lake and for helping us to get the word out

By growing membership, and with your generous donations, we have grown our funds by \$18,000 over just the past 2 years. As you can see by our total expenditures this past year we have made great strides at minimizing administrative costs, and your emails have greatly reduced printing and mailing costs. In addition to the \$254 spent clearing the outlet, we had 178 total VOLUNTEER hours from members - making this a very inexpensive solution to last year's high water problem. Also note that we received \$180 for advertising in our directory - and we hope you utilize the great services that some of our members provide. Membership directories will be available for pick up at the Spring Membership meeting on April 26. The LSIA's financials are audited each year by a non-board member. We want to thank John Wise for his audit services! Know that the majority of our funds will likely be targeted for whole-lake AIS weed treatments over the next 3 to 5 years. If you care how we best use these funds, please come to the general membership meetings - or volunteer for the Board!

The Loretto Creek Phosphorus Removal Project Gets Approved!

The construction of a sedimentation and water quality pond behind the Loretto ballfields this summer will directly benefit Lake Sarah by reducing phosphorus loading by an estimated 140 lbs per year. We want to both thank and congratulate the cities of Medina and Loretto for their joint teamwork and diligence in submitting a Clean Water Land and Legacy grant application for the 3rd year

Zebra Mussels

Zebra Mussels are our newest Aquatic Invasive Species (AIS) threat.

Many Minnesota recreational lakes have been or soon will be infested with this non-native aquatic invasive species. Action now may delay or prevent our lake from being infested by zebra mussels. Boaters and lakeshore property owners must do everything possible to learn about this invasive and take every action possible to help reduce it's spread. Public Access and Landing Update

LSIA submitted a grant to the DNR for Boat Inspection at the public access for Aquatic invasives species (AIS) (specifically zebra mussels). 200 hours were requested with the DNR matching another 200 hours. Unfortunately our request was denied.

The city of Greenfield submitted a similar grant for local government units and was awarded 70 hours of inspection time by certified DNR inspectors. So look for them at the access soon.

LSIA also submitted a grant for a new and current AIS signs for the public access. The signs were supposed to be available now, but due to extenuating circumstances, will not be available until later this summer. LSIA is considering making our own signage for the access area to keep those using landing informed about the dangers of invasive species. LSIA is also planning to build a kiosk to mount all signs. This will help to de-clutter the access and make signs more visible.

I recently took the Service Provider Training course put on by the DNR for AIS. So if anyone has any questions, feel free to email me. scottwalsh@aol.com I would hope that I can answer

most questions.

Be careful when buying used equipment and make sure that they are AIS free. They should have been cleaned properly or been out of the water for at least 21 days. Boat lifts, docks, and other equipment can unknownly harbor zebra mussels and you could accidentally introduce them into the lake without knowing it. Let's help keep Lake Sarah free of Zebra mussels!

And finally, please inform me of any boating hazards not currently marked on the lake (rocks, logs, etc.) and I will make sure they get marked. Thanks!

- The all time low water level in recent history is 977.78, set on August 10th 2007
- The all time high water level in recent history is 982.40 on June 28th, 2002. Ordinary high water level for Lake Sarah is 979.9
- Weir height set by DNR is 978.80

About the Beach Buddy

The Beach Buddy is an eco-friendly solution to saving Lake Sarah. It will help get rid of the weeds in Lake Sarah that release a lot of phosphorus. It is an easy to use beach tool with a blade that digs the weeds out (possibly removing them by the roots) and tongs that catch the weeds as they are cut. We hope you'll allow us to help Lake Sarah by using this method instead of chemicals.

What We Are Doing

We will use the Beach Buddy by pulling out 2500 square feet of submergible weeds from the lake by your shoreline. Basically the same area as chemical treatment, but cheaper. Also, we will haul the weeds to Mel's vegetable farm on County Road 55 with our truck and trailer and he will be using the weeds as fertilizer for his vegetables. All shorelines are different so we will assess each job on site.
